The program offers a thorough overview of the firm and the opportunity to hear from our founders and senior leaders. You will receive on-the-job training with various divisions across the firm in Hong Kong, Macau and Mainland China, and will be given day-to-day responsibilities to contribute to our teams throughout the Program, including giving us fresh ideas to grow our businesses. At Micro Connect, we are highly committed to providing young talents with a dynamic, exciting and unconventional learning experience while identifying outstanding individuals to support the long-term growth of our businesses.

What to Expect

This Program offers hands-on experience with extensive training. You will spend 8 weeks with our teams learning about our business model, products and services by immersing yourself in day-to-day activities of one of our divisions. You will make an impact by:

- Participating in the full cycle of our alternative investment process
- Analyzing market data, building financial models and preparing client presentations

Eligibility

We actively seek to recruit talented students from all academic backgrounds into our Internship Program. The Program is open to candidates obtaining their Bachelor's or Master's degree from Hong Kong, Mainland and overseas colleges / universities and preferably in their penultimate or final year of study.

Authorization to work in Hong Kong: Candidates will need to ensure they have the proper work visa / permission to take up internship in Hong Kong. Final offer and eligibility will be subject to

internship-related policies of Hong Kong's Immigration Department, including endorsement by the institutions at which the candidates are currently enrolled.

Time Period

8-week Program during summer 2024, starting around mid-June 2024.

Functions

Interns will be working with our teams across the following functions during the course of the program:

MCEX Exchange Platform – Support the development of Micro Connect Macao Financial Assets Exchange (MCEX) in Macao, the first licensed global exchange for Daily Revenue Obligations (DROs), a new asset class which connect international capital with micro businesses, and facilitate the design and development of innovative exchange products

Branding & Marketing – Building brand awareness by organizing events and community activities, preparing PR announcements, updating the company websites, and other social media / content marketing channels

Capitals & Funds – leading the investor communications effort for MCEX and related products and providing solutions to a wide range of investors globally

Corporate Development – setting firmwide strategy and developing / executing plans for new businesses and growth initiatives

Risk – providing analysis of market dynamics and business activities and establishing processes to monitor and manage MCEX risk exposures

Research Institute – conducting research and analysis to support production of research reports and help coordinate collaborative projects with external stakeholders

Finance – managing the firm's liquidity and overall financial control / reporting

Information Security – developing technological solutions that drive our innovative business model

Legal & Compliance – providing advice to all areas of the firm and maintaining the firm's reputation

Human Resources – providing data analytical support to ensure data integrity and accuracy in generating metrics on our workforce to help decision-making in connection with training needs and implementation of employee well-being initiatives

If your application is selected, you will be asked to participate in 2 to 3 round interviews, each of which will take approximately 30 minutes to complete.
